ENTRY TO RUSSIA FOR FOREIGN PARTICIPANTS

DOCUMENTS FOR CROSSING THE BORDER

To avoid encountering any problems when crossing the border, all foreign participants arriving from abroad are required to bring the following documents:

If you **need** a visa to enter the Russian Federation

You must bring the following to cross the border:

- a visa:
- · a valid passport;
- a medical insurance policy valid in the Russian Federation.

If you **do not need** a visa to enter the Russian Federation

You must bring the following to cross the border:

- a valid passport;
- a medical insurance policy valid in the Russian Federation.

HOW TO APPLY FOR A VISA?

If you need a visa to enter the Russian Federation, you can:

- receive a visa through an invitation for foreign arrivals (for all EEF participants);
 OR
- 2) receive an electronic visa (available for citizens of 55 foreign countries).

VISA ON AN INVITATION FOR FOREIGN ARRIVALS

After submitting all the required documents, Forum participants can obtain a short-term, singleentry Russian visa **for the period from 24 August to 16 September 2024** at consular offices of the Russian Federation on the day of their application.

You can generate the invitation in the <u>Roscongress personal account</u>. Your personal information will be automatically uploaded from the Roscongress personal account to the document. You can manually add the city and country where you will be applying for your visa.

If you have found any errors in your personal data in the application for participation, you can contact a Roscongress Foundation specialist to make changes to the personal data.

Download and print the invitation for foreign arrivals. Provide your Russian consular office with the invitation for foreign arrivals and the other required visa documents.

To receive a visa for entry into Russia, individuals in possession of an invitation must apply at the relevant foreign consular office of the Russian Federation. Information about the location of Russian consular offices can be found on the website of the Ministry of Foreign Affairs of the Russian Federation.

E-VISA

Citizens of 55 foreign countries are eligible for e-visas.

Andorra, Austria, Bahrain, Belgium, Bulgaria, Cambodia, China, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, India, Indonesia, Iran, Ireland, Italy, Japan, Kuwait, Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Mexico, Monaco, Myanmar, Netherlands, North Korea, Northern Macedonia, Norway, Oman, Philippines, Poland, Portugal, Romania, San Marino, Saudi Arabia, Serbia, Singapore, Slovakia, Slovenia, Spain, Sweden, Switzerland, Taiwan, Turkey, Vatican City, Vietnam.

The unified electronic visa is a single-entry visa. The validity of the single electronic visa is **60 days** from the date of issue. The permitted period of stay in the Russian Federation on a single electronic visa is **not more than 16 days** from the day of entry within its validity period.

The unified electronic visa is not free. To apply for a unified e-visa, it is necessary to fill in an application on the purpose-made website of the <u>Ministry of Foreign Affairs of Russia</u>.

ARRIVAL IN VLADIVOSTOK

BY AIR

Vladivostok International Airport is Vladivostok's only airport that serves scheduled flights. The travel time from Vladivostok International Airport to FEFU is approximately 60 minutes, depending on traffic.

On 30 August – 5 September <u>accreditation points</u> where participants can obtain their accreditation badges and <u>PCR testing centres</u> will be available at Vladivostok International Airport, Arrivals area. Information and services point will be staffed to provide Forum participants with all the necessary information.

During the Forum, free shuttles will run between Vladivostok International Airport and the Forum venue. Participants can use the accredited vehicle with driver rental service.

ARRIVING BY PRIVATE JET

If a participant or group of participants is planning to arrive in the Russian Federation by private aircraft, but there are no direct flights between the country of departure and Russia at the time, it is necessary to request permission in writing to land the private jet and send it to the Roscongress Foundation.

Regardless of whether there are direct flights between the departure country and Russia, all participants arriving in Russia by private jet must submit a request to land the aircraft according to the operating regulations of Vladivostok International Airport.



BY SHIP/PRIVATE YACHT



ARRIVAL AND PARKING OF VESSELS AT VLADIVOSTOK BAYS

From 00:00 on 2 September 2024 to 24:00 on 6 September 2024, you must have an application approved by the Organizing Committee to access the waters of Peter the Great Bay in Novik Bay, which are bound from the northwest by a line from Cape Doronin to Cape Shigina, the waters of Ajax and Paris bays, which are bound from the northeast by a line from Cape Novosilsky to Cape Zhitkov, as well as the waters of Amur Bay under a low-water bridge with a 500-metre exclusion zone to the west and east of the bridge.

Approved vessels must additionally agree their time of arrival by telephone: +7 (423) 249 8407, +7 (423) 249 8447.

FORUM VENUE

The EEF 2024 business programme events will take place at the Far Eastern Federal University (FEFU) campus.

The journey time from the city centre to the FEFU campus is approximately half an hour while the journey time from the airport to the FEFU campus is approximately one hour.

EEF 2024 VENUE LEVEL MAP

Due to the uneven terrain, the buildings of the Far Eastern Federal University (FEFU) are located at different levels.



In the information materials and on signposts at the Forum venue, a short designation for the location of specific venues is used, where the letter means the building (A, B, C, D, G, L, M, S), and the digit means the level (from 1 to 12).

Detailed maps of the levels can be found in the <u>'Venue maps'</u> section of Forum website and in the Roscongress mobile app. Information and services points and Forum personnel will be available to provide assistance in locating specific venues.

ACCESS TO THE FORUM VENUE

HOW TO GET TO THE FORUM VENUE?

Pick up your badge.

We kindly ask that you collect your accreditation badge in advance at one of the accreditation points in Moscow or Vladivostok. To pick up your badge, please check that you have uploaded all the necessary data to your Roscongress personal account.

102 Take a PCR test.

The badge will be active once you present a negative PCR test result for COVID-19.

You do not need to take a PCR test to collect your badge. You can collect your badge and then take a PCR test or do it in the reverse order.

More information on time frames, testing centres, payment procedure and booking are available in the 'PCR testing' section.

Plan a route to the Forum venue.

Participants have a number of options for getting to the Forum venue:

- By free Forum <u>shuttle buses</u>
- By rented vehicle
- By personal <u>accredited vehicle</u>
- · By personal non-accredited vehicle or taxi.

VIEW THE SCHEME OF THE FEFU TERRITORY

Leave items prohibited at the Forum venue at the accommodation.

Upon arrival, each participant will have to go through the access control procedure. You may be asked to turn on your phone or laptop and show other equipment that you brought to the venue.

Please carefully review the list of items prohibited on the Forum venue and pay attention to any exceptions.

05 Don't forget your passport

Please don't forget to bring along an identifying document (passport) to the venue. You must present your passport at the checkpoints and keep it with you while you are at the Forum venue.

BADGE COLLECTION

The EEF venue and a number of cultural, sports and entertainment programmes events may only be accessed if you have an accreditation badge.

An accreditation badge is invalid without a negative PCR test result.



Participants are kindly asked to collect their badges in one of the accreditation points in Moscow or Vladivostok in advance.



It is required for participants to have on hand their badge and identity document (passport) at all times while at the Forum venue. The badge is personalized and may not be transferred to third parties.

If the accreditation badge is lost or damaged, please go to the Help Desk or any accreditation stand.

Before receiving a badge, please make sure that the following conditions in the Roscongress personal account have been observed:

- 1. Participation in the Forum is confirmed
- 2. The personal information is indicated in full according to the passport data
- **3.** A required photo for your badge is uploaded:
 - · Colour photo against a light background
 - Photo size 480 × 640 pixels
 - Photo format JPG or JPEG
 - Full-face photo with no headgear
 - Your face must take up at least 70% of the photo
- 4. A scanned copy of your passport (pages 2 and 3) is uploaded

Tab 'My events – EEF – Event dashboard – Personal information – Edit data'.

Please make sure that the scanned copy is legible and contains complete information about the data you gave when registering, including the series and number of the document, the issuing date, the issuing authority, and a photo.

Formats: JPG, JPEG, PDF, PNG.

5. Participation fee is paid

If there have been any changes to a participant's ID since the application was completed, their personal data needs to be updated in the Roscongress personal account accordingly. If changes need to be made to fields that cannot be edited, a participant should inform Roscongress Foundation specialist whose contacts are indicated in the Roscongress personal account.

Before issuing a badge, an accreditation point attendant will make sure that the data specified in the Roscongress personal account corresponds to the ID document. In the event of any discrepancies, it will not be possible to issue a badge the same day.

Please note that if you are arriving at the Forum venue in an accredited vehicle, the driver must also be accredited.

HOW DO I KNOW WHEN MY BADGE IS READY?

There are several ways to find out or being notified when a participant badge is ready:

- An email notification
- A notification in the participant's Roscongress personal account
- A call to the Forum information centre: +7 (499) 7000 111
- A call to a Roscongress Foundation specialist. The contact information can be found in the Roscongress personal account (on the right of the photo in the 'My events – EEF – Event dashboard' tab).

HOW DO I PICK UP MY BADGE?

Badges may be collected **in person** (upon presentation of the identity document (passport), whose details are indicated in the <u>Roscongress personal account</u> and an original of personal data consent form) or **by a power of attorney**.

If a participant's badge is collected by a third party using a power of attorney, the authorized person must present the following:

- Authorized third party's passport
- Original standard power of attorney
- List of participants
- Copies of the passports of all participants to be accredited
- Originals of personal data consent forms

A personal data consent form, a power of attorney form, and an example of how to complete it are available for downloading in the 'Badge collection' section of the Forum website.

WORKING SCHEDULE OF THE ACCREDITATION POINTS

PCR TESTING AND BADGE ACTIVATION



In order to access the FEFU campus from **07:00 1 September to 23:59 6 September** (Vladivostok time, GMT+10), all participants must take a PCR test for the COVID-19. One PCR test for the entire duration of the Forum **must be taken 24 hours before visiting the Forum venue.**

PCR test for access to the Forum venue can be submitted **from 07:00 on 30 August** (Vladivostok time, GMT+10).

A single test is sufficient for attendance at all Forum events, except the plenary session and events with the participation of the President of the Russian Federation. Plenary session attendees must take the PCR test 24 hours before the event.

The badge is activated automatically by a negative test result. The test result is valid for visiting the venue until the end of the Forum.

Results will be provided within 24 hours, for the loop-mediated isothermal amplification (LAMP) method – 4 hours.

If a participant arrives at the venue by personal accredited car with a driver, then the driver must also take PCR test. The participant needs to register the driver for testing in their Roscongress personal account.

WHEN TO GET TESTED?

You live in Primorsky Territory or arrived in Vladivostok before 31 August	Participants who live in Primorsky Territory must take a PCR test at one of the dedicated EEF 2024 testing centres 24 hours before arriving at the venue for the first time. Test result is valid until the end of the Forum.
You are departure into Vladivostok from another Russian region on 1 September and later	Participants who are arriving to Vladivostok from another region of Russia must take a PCR test and get a negative result before departure. The test result is valid until the end of the Forum. If you have booked accommodation on the FEFU campus, you must have an active badge to enter the area from 07:00 on 1 September. For this purpose, you must take a PCR test no earlier than 48 hours before departure to Vladivostok. The test result will be valid until the end of the Forum.
	If you plan to stay in Vladivostok, you must take a PCR test not earlier than 48 hours prior to your departure to Vladivostok and have an active badge for access to the Forum venue. Take a PCR test at one of the Forum's dedicated testing centres, which are provided by Rospotrebnadzor.

TESTING FOR ACCESS TO THE PLENARY SESSION AND EVENTS WITH THE PARTICIPATION OF THE PRESIDENT OF THE RUSSIAN FEDERATION

To attend the plenary session of the Forum and the events with the participation of the President of the Russian Federation, you will need to retest.

Please note that access to these events is by special invitation only; you will be invited in advance. The invitation to the plenary session will be sent by email.

The test must be taken 24 hours before the event. Take a PCR test at one of the Forum's dedicated testing centres, which are provided by Rospotrebnadzor.

HOW TO GET TESTED?

- Provide information about COVID-19 immunity in the Roscongress personal account.
- **<u>02.</u>** Find your ID in the Roscongress personal account and keep it in mind or write it down.
- **03.** Sign up for PCR testing in the Roscongress personal account.
- **04.** Pay for PCR testing.
- Print, fill out and sign consent forms for medical intervention and to the processing of personal data.
- <u>**06.**</u> Provide your Forum participant ID at the Forum testing centre or using the off-site testing.

DATA REQUIRED FOR TESTING

1. Information about your immunity to COVID-19

In order to be admitted for PCR testing, all participants must provide information about their immunity to COVID-19 in the <u>Roscongress personal account</u>:

- information about COVID-19 vaccination status;
- information about previous coronavirus infection (COVID-19) status;
- information about permanent residence and temporary addresses in Vladivostok during the events.

2. Forum participant ID

The ID is a participant's identification number in the Roscongress personal account. You can view your ID:

- on the badge (if it has already been received);
- in the 'Personal data' section of the Roscongress personal account next to the participant photo.

If a test is not associated with a participant ID, it will not be possible to send the test results to the Accreditation Centre in order to activate the badge to attend the event.

3. Consent forms for medical intervention and to the processing of personal data

For participants planning to take a PCR test in Moscow, you must print, fill in and sign a medical treatment consent form before visiting the testing centre and bring it with you. Medical treatment consent form is available in the 'Documents required for testing' section of the Forum website.

WHERE TO GET TESTED?

Testing will be carried out only at the Forum's dedicated testing centres, which are provided by Rospotrebnadzor in Vladivostok, Moscow and St. Petersburg. **The results of tests taken at other laboratories will NOT be accepted**.

VIEW THE LIST OF TESTING CENTRES

BOOKING A TEST

PCR testing at dedicated Forum testing centres is strictly by appointment only. In the Roscongress personal account, go to the 'My events' section and choose 'EEF 2024', then open the 'Event dashboard – PCR testing' tab. In the 'PCR testing – Book a test' section, choose the most convenient testing centre from the list and select a time slot.

Please note: In order to book a PCR testing, you must:

- fill in all the required fields of the questionnaire in the 'Data about immunity' section;
- fill in contact information and E-mail. It is not necessary to confirm the phone number.

Accredited drivers can book a test via the <u>Roscongress personal account</u> of the participants that accredited their drivers.

PAYMENT FOR PCR TESTING

In order to pay for a test, you must provide the Forum participant ID of the person whose PCR test is being paid for.

Contracting for testing is done according to the schedule: 2–24 August (09:00–18:00); 25–30 August (07:00–21:00); 30 August – September 6 (24h). Moscow time (GMT+3).

LAMP TESTING

Forum participants and media representatives may test for COVID-19 by the <u>loop-mediated</u> isothermal amplification (LAMP) method. Results are available within 4 hours.

To get tested, sign up using your <u>Roscongress personal account</u>. In the list of testing centres, select those with the LAMP prefix.

At the testing centre, please inform the staff that you plan to be tested using the loop-mediated isothermal amplification method.

TEST RESULTS

Lab results will be provided within 24 hours. Before going to the Forum venue, please make sure that your test result is negative and your badge is activated. You can check the test result in the 'PCR testing – Test results' section in the <u>Roscongress personal account</u>.

If you don't get the test result, you can find out information:

- by calling the Forum information centre at +7 (499) 7000 111;
- by calling your Roscongress Foundation specialist.

ACCREDITATION OF PERSONAL VEHICLE

Please note that a limited number of vehicles are allowed on the FEFU campus. We recommend using the shuttle buses instead.

Accredited vehicles have the right of access to the following locations (depending on the type of transport pass and the parking index assigned to it):

- the FEFU campus and one of the parking areas at the FEFU campus (GR-2B, GR-4, parking areas at the buildings K);
- pick-up/drop-off zone near the main entrance to building A (level 6) and off-site parking areas C, D, E;
- pick-up/drop-off zone and parking area at Vladivostok International Airport;
- · parking areas at suggested Forum hotels;
- pick-up/drop-off zones and parking areas at cultural and sports and entertainment programme event locations.



Each transport pass is issued to a single specific vehicle and is linked to the vehicle's data (mark, model, and registration number) and access rights to the FEFU campus and parking areas.

It is forbidden to transfer a transport pass or driver's badge to a third party. Should this occur, the pass and/or badge will be withdrawn and annulled.

Accredited cars are issued with transport passes; drivers must also be accredited.

Transport passes and drivers' badges may be collected in person upon presentation of ID (passport) or by a third party (proxy) by power of attorney at Accreditation Centre 1 (FEFU campus, building M).

PAYMENT FOR PARTICIPATION AND SERVICES

To pay for participation in the Forum, you should create a participation agreement or an invoice agreement, both of which confirm and guarantee participation.

CREATING A PAYMENT DOCUMENT

The payment document is created as follows:

- go to the 'My events' section of the Roscongress personal account;
- select EEF:
- go to the 'Event dashboard' section;
- · open the 'Payment' section;
- enter the payer's information (make sure you enter the information of the individual or legal entity making the payment);
- select the payment method;
- select the type of payment document: a participation agreement or invoice agreement (a single document incorporating both the agreement and invoice for payment).

MAKING THE PAYMENT

There are two ways to pay for participation:

- By invoice. To pay by invoice, the payer should contact their bank.
- By bank card. Acceptable payment forms include Visa, Mastercard, American Express, UnionPay, and MIR payment system cards issued by Russian banks and UnionPay payment system cards issued by foreign banks.

The participation fee may only be paid by the individual or legal entity indicated as the Customer in the participation agreement (invoice agreement).

Should you have any questions regarding payment (including if the payment does not go through). you can get in touch with your Roscongress Foundation specialist. The contact information can be found in the Roscongress personal account.

PAYMENT AT THE FINANCIAL SERVICES STANDS

Participants can pay the participation fee and the cost of any services provided by the Roscongress Foundation at the financial services stand at the Accreditation Centre 1 (building M, FEFU campus). The Forum financial services stands also issue closing documents.

A 5.5% commission is charged when paying for participation and services at the financial services stands. Participants can pay:

- in cash (Russian roubles);
- by Visa, Mastercard, American Express, UnionPay, and MIR payment system cards issued by Russian banks:
- by UnionPay payment system cards issued by foreign banks;


BRICS CREATIVE INNOVATIONS FORUM



'FAR EAST STREET' EXHIBITION

The 'Far East Street' exhibition is a unique place for leading Russian and international professionals in economics, public administration, and the Russian and Asia-Pacific region business communities to come together.

All **11 regions** of the Far Eastern Federal District will showcase their best projects, featuring a vibrant cultural programme, unique handicrafts, and original cuisine at the 'Far East Street' exhibition. Masterclasses, tastings, interactive installations, sporting events, demonstrations, and fairs for local producers, as well as film screenings and the sale of unique jewellery, locally branded clothing, and souvenirs, are planned in the pavilions.

Far East Street will also feature:

• 'Developing the Far East' – the pavilion of the Far East and Arctic Development Corporation.

The pavilion features an interactive exhibition of products from companies established in the territories of advanced development and the Free Port of Vladivostok. Additionally, it offers consultations on the practical application of state support mechanisms, acquiring land free of charge in the Far East and the Arctic, and provides services for citizens and entrepreneurs.

• Two pavilions of the Ministry of Sport of the Russian Federation.

The 'Ministry of Sport of the Russian Federation' pavilion serves as a platform for business sessions and the signing of agreements in the field of physical culture and sports. Here, discussions will take place on topics related to high-performance sports, international cooperation, and new formats for sports competitions.

The **Sports Arena** pavilion is the centre of sports activities at EEF 2024. The 'GTO Games' Open Cup of the Far East will be held here. In addition, all visitors will be able to complete the standards of the All-Russian Physical Culture and Sports Complex 'Ready for Labour and Defense' (GTO) and find out what mark of distinction their physical fitness corresponds to.

- Next to the Falcon House, the Embassy of the United Arab Emirates, in collaboration
 with the Roscongress Foundation, organizes an exhibition of traditional Bedouin tents
 called the Arabian Village. Guests of this exhibition will be invited to taste real Arabic
 coffee and sweets prepared according to ancient recipes, to dive in the hospitality
 of the inhabitants of the Middle East.

- Pavilion of JSC 'Corporation Tourism.RF', where opportunities for investing in tourism infrastructure and tourism development projects, both in the Far East and other regions of Russia, will be discussed.
 - A convenient business space will be organized on the site, where presentations of investment projects, thematic sessions with partners and the signing of cooperation agreements are planned. Guests of the forum will enjoy a diverse cultural program with tastings of local cuisine and live music.
- The traditional **Regions Cuisine** will provide an opportunity to taste real Far Eastern delicacies.



- The 'Hunter's Day' career project, which aims to solve the problem with understaffing in the regions and attract young specialists to local enterprises.
- The 'Dream Team' consists of a team from the Roscongress Foundation's Participant Relations Directorate and is a full-fledged educational centre where hundreds of students and university graduates undergo training and internships every year. The Dream Team implements special training and career growth programmes, and has developed effective and modern training and a knowledge base using online courses on its own educational platform, KLUCH.PRO.
- 'Country's Human Potential: Careers' is a technological space that provides opportunities
 to young professionals and university graduates without work experience. A chatbot provides
 information about vacancies and internships for young professionals without work
 experience, including for people with disabilities.

In the chatbot, applicants can find basic information about companies, vacancies, and internships in specific regions, industries, and selected professions. The 'People with Disabilities' section presents career programmes for people with disabilities.

'Country's Human Potential: Careers' offers:

- A chat bot with a database of numerous vacancies and internships being offered by the country's leading companies
- An opportunity for specialists without work experience to build a career
- Direct access for companies to proactive and motivated young people
- Career opportunities for people with disabilities.

CURRENCY AND BANK CARD TRANSACTIONS

CURRENCY EXCHANGE

Please note the following currency exchange restrictions in the Russian Federation:

- only USD and EUR cash can be freely exchanged for RUB cash;
- you must present your ID (passport) for transactions over RUB 40,000;
- there is NO exchanging of non-cash currency for RUB cash using Mastercard or Visa bank cards issued outside of Russia. It is also not possible to withdraw RUB cash from these cards.

BANK CARDS

We recommend bringing enough cash with you for the entire duration of EEF due to restrictions on the use of foreign bank cards in Russia.

The use of MIR and UnionPay cards in Russia is not restricted in any currency. We recommend that EEF participants get a new card/bring an existing card that uses one of these systems, if possible.

Please note that UnionPay has started its operations in Russia relatively recently. Therefore, cards using this payment system may occasionally malfunction.
